

“Martin’s Super Market Guest Experience Grocery Giveaway” (The “Sweepstakes”) Official Rules
No Purchase Necessary. Open only to legal residents of the United States of America or Washington D.C.
Participant must be 18 years of age and older as of date of entry. Void in Florida, Rhode Island and

1. Promotion Period: The “Sweepstakes” begins at 12:00 a.m. Eastern Time (“ET”) on January 1, 2025
and may continue until Martin’s Super Market ends its relationship with the Survey Vendor, The
Feedback Group (“FG”), until Martin’s Super Market chooses to end or alter the Sweepstakes, or 11:59

free (866)-364-0813 for the instore shopping experience and complete a survey. At the conclusion of our
Internet/Telephone survey, you will have an opportunity to provide your ‘Sweepstakes’ entry

Email Address or Telephone Number will be kept confidential and will only be used to notify you in the
